

Pursuant to Section 4-9-30(5)(a)(i) of the South Carolina Code of Laws 1976, as amended (the "Code"), and by this petition, the undersigned electors of Legends Drive Special Tax District request the Horry County Council provide for the creation of the below described special tax district and in turn certify the same via resolution to the Horry County Election Commission so a special election may be held:

A. Name of proposed special tax district: **Legends Drive Special Tax District ("Legends Drive STD")**

B. Purpose of proposed special tax district:

The undersigned electors request that Horry County (the "County") take title to, repair and upgrade to the current standards required by Horry County Road Maintenance System under Chapter 16, Art. III, Horry County Ordinance, as determined by the Horry County Engineer and Director of Public Works (the "System"), the road known as Legends Drive (from US 501 up to the guard house, as shown on the attached sketch attached hereto as Exhibit A, and made a part and parcel hereof) for the specific purpose of having the County accept the Legends Drive into the System, including, without limitation the following:

1. Maintain and Paving Legends Drive
2. Road Signage on Legends Drive
3. Road Drainage on Legends Drive
4. Public Safety, including security and police protection
5. Disaster Preparedness and Cleanup
6. Cost and Expenditure of administration including office and clerical costs and the employment of the necessary professional, or other persons or entities necessary to carry on the business of the special tax district
7. Liability Insurance, to the extent same may be necessary and to the extent same is not covered by the S.C. Insurance Reserve Fund, for that portion of the roads and any common areas, if any, of the special tax district, owned by the special tax district, as well as the Commissions of the Special Tax District and the County.

C. Designation of the boundaries of the proposed special tax district:

The undersigned electors request that the County designate all of those One Thousand Two Hundred Sixteen (1,216) individual tax parcels of real property currently located within Legends Drive as of April 16, 2024 (the "Legends Drive Parcels") and being more particularly described and listed on the attached Exhibit B which shall be made a part and parcel of this petition and incorporated herein by reference if set forth verbatim herein. It being expressly understood that any future lot(s) subdivided from or consolidated with any of the existing Legends Drive Parcels would be subject to and a part of the proposed special tax district contemplated by this petition entitling a qualified elector to vote in the subsequent election.

D. Nature of services to be rendered for the proposed special tax district (the "Project"):

The undersigned electors request the County to repair and upgrade Legends Drive to bring it up to the standards required for the County to accept Legends Drive into the System, as more particularly stated in the attached Combined Estimate – US 501 to Gate House (Includes widening to 3 lanes from US 501 to ditch crossing), made a part and parcel here of as Exhibit C.

The undersigned electors acknowledge that when the County accepts Legends Drive into the System, the County will be responsible for the upkeep and maintenance of Legends Drive at the same level of service the County provides other similar County roads in the System.

E. Operation of the proposed special tax district:

The proposed special tax district shall be operated by a five (5) member special tax district commission ("Commission") consisting of resident freeholders of the Legends Drive Special Tax District to be appointed by the County Council for a four (4) year, staggered terms.

F. Maximum level of taxes authorized to be levied and collected for the proposed special tax district:

The Legends Drive STD Electors acknowledge that the County currently estimates that the cost of the Project including costs associated with the issuance of debt will be Two Million Three Hundred Forty Seven Thousand and 00/100 (\$2,347,000.00) and that the County will issue special purpose bonds and/or special purpose bond anticipation notes with a term of fifteen (15) years to provide funds needed to pay the costs of the Project and costs associated with the debt. The anticipated maximum millage rate based on the tax assessed values and cost estimates available at this time shall be no more than 16 mils.

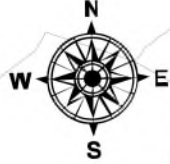
The Legends Drive STD Electors request and authorize the County to levy and collect a tax on all taxable property within the proposed special tax district as may be required to pay the cost of the Project or principal, interest and all costs associated with any debt issued by the County. The maximum amount to be repaid from the levy and collection of taxes will not exceed the amount necessary to pay principal and interest on the amount borrowed by the County to pay the cost of the Project and all costs associated with the any debt issued by the County.

The undersigned electors of Legends Drive, consisting of fifteen percent (15%) or more of the Legends Drive total electors, have signed this petition of their own free will and initiative and request that an election be held in Legends Drive pursuant to Section 4-9-30(5)(a)(i) of the Code and for the purposes stated above:

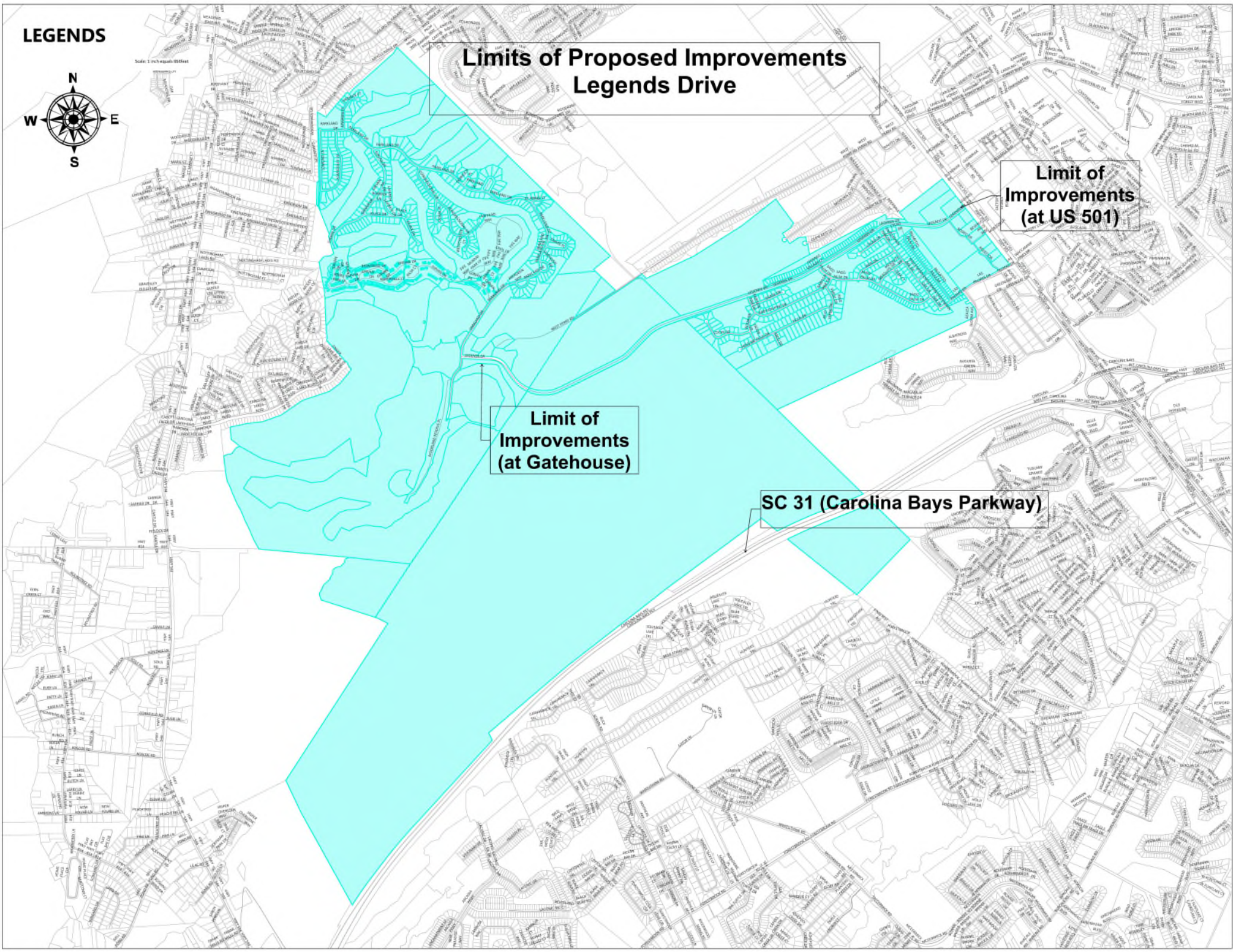


**Limits of Proposed Improvements  
Legends Drive**

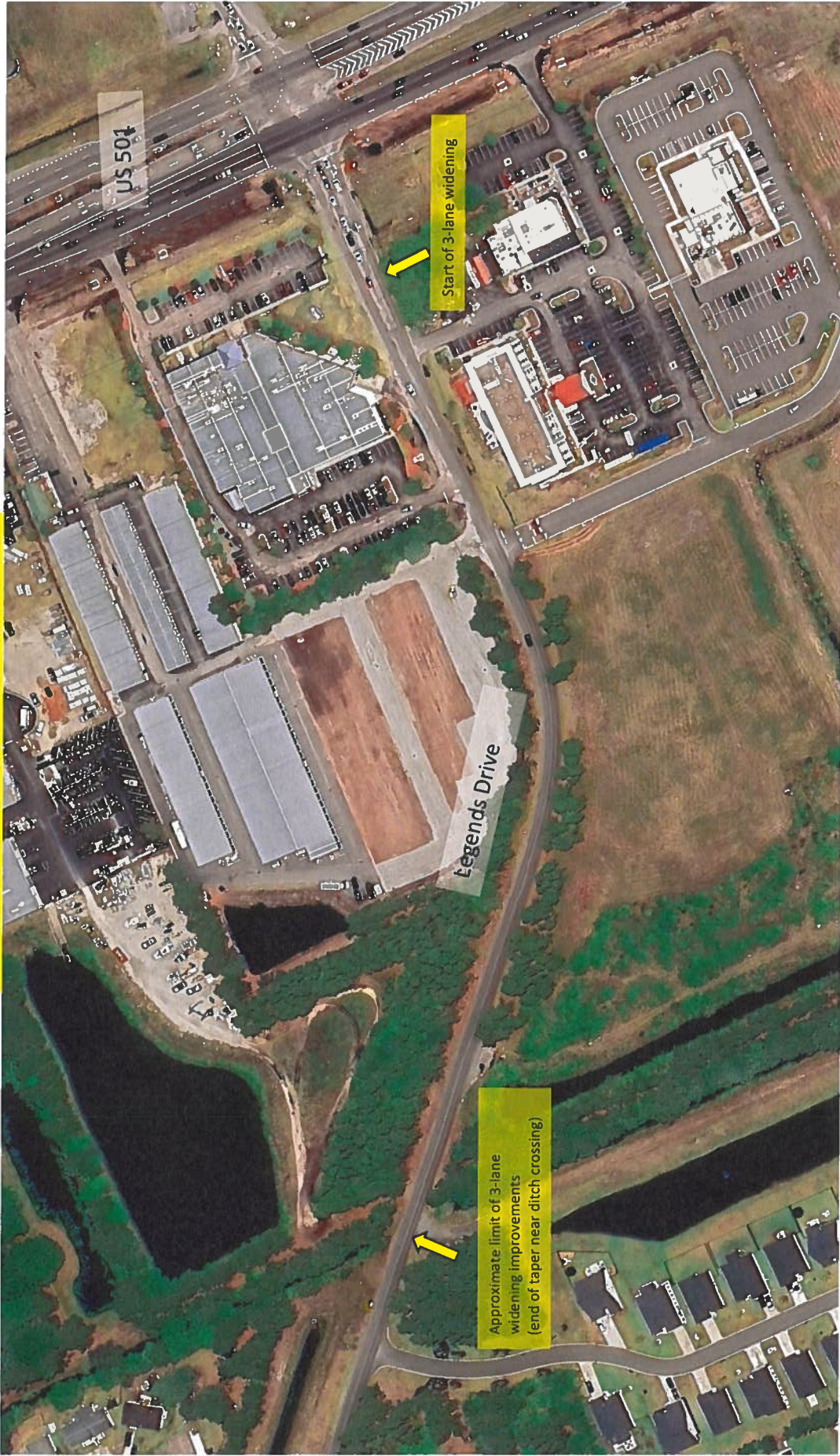
**Limit of
